January 21, 2026, Board meeting called to order at 3:34 p.m. by President Dana Shaw

Old Business:

- 2026 Budget was looked and talked about. Mike Newbanks moved to approve the 2026 Budget and Chad Towns 2nd the motion to approve the 2026 Budget. It was voted on and approved to accept the 2026 Budget for Yuma County Pest Control District
